

The Premises Identification (PID) Program is used to track the location of animals in case of an health emergency occurrence, a public health emergency, or an emergency such as a natural disaster affecting animals and people. On January 1, 2009, regulations requiring premises identification became law as part of the Animal Health Act.

A “premises” means the area of land contained in a legal land description or identified by geo-referenced coordinates and is where recordable animals are bred, kept, raised, displayed, assembled or disposed of. “Recordable Animals” are animals from those species listed in the attached Premises Information Sheet for Animal Owners and Commingling Site Operators, Schedule A, Part I.

An owner of a recordable animal must apply for a premises identification account and at least one premises identification number within 30 days of assuming ownership of a recordable animal.

An operator of a “commingling site” shall obtain a premises identification account and at least one premises identification number for each commingling site operated by the operator within 30 days of assuming ownership of a “commingling site”. “Commingling Sites” include those listed in the attached Premises Information Sheet for Animal Owners and Commingling Site Operators, Schedule A, Part H.

<ol style="list-style-type: none"> <li>1. Complete and sign a PID Account Application Form. Check “New Applicant” box.</li> <li>2. If an animal owner, complete Schedule A for at least one premises, preferably your home quarter. A home quarter means the premises on which your main animal operation is located. (Note: If you have multiple premises, you have the option to complete a Schedule A for each additional premises.)</li> <li>3. <b>If an operator of a commingling site</b>, complete a Schedule A for each commingling site you operate.</li> <li>4. If the animal owner, operator of a commingling site <b>already has obtained a premise ID number</b> from either the Canadian Cattle Identification Agency (CCIA) or the Alberta Pork Producers Development Corporation, this number must be provided in Part E.</li> </ol>	<ol style="list-style-type: none"> <li>1. Check “Update an Existing PID Account” box on a PID Account Application Form. Complete and sign this form. If required, provide any updates to the general information in Part A.</li> <li>2.
